#### State Street Blue Line Modernization Project Ribbon Cutting

On Thursday, May 26, 2011, at 11:00 am an official ribbon cutting ceremony will be held at the new 60 State/Congress Street entrance to State Station. State, city, and local officials, including the AACT chair, will gather at the newly modernized Blue line section of the station to celebrate the completion of many major station renovations.

# Proposed Red Line Single Person Train Operation

#### MBTA to Host APTA National Rail Conference & Rodeo

The MBTA is hosting the American Public Transportation Association (APTA) Rail Rodeo and Rail Conference June 9 -15, 2011. The Rail Rodeo (June 9 – 12) tests the skills of national and international rail operators and maintenance employees. For the first time the Rodeo will feature a test on assisting customers with disabilities. The Rail Conference (June 12 – 15) consists of discussions and workshops on a wide variety of topics including safety and security, planning finance, capital projects, etc. Staff from System-Wide Accessibility will be participating in a workshop on Quality Assurance Techniques to Improve System Accessibility.

**Phase 2 Bus Recertification Training:** 2-hour ADA Refresher training module with both classroom and hands-on instruction onboard the bus. Includes state-of-the-art bus simulator. Due to space restrictions maximum class size 6 students; 1 observer (and Personal Care Assistant, if applicable).
