RE **Assumptions for Development of the Revised Staff Recommendation**

- FFYs 2013-16 Transportation Improvement Program

The purpose of this memorandum is to introduce a Revised Staff Recommendation for the FFYs 2013-16 Transportation Improvement Program (TIP). A Revised Staff Recommendation is needed because since March 23, staff received updates to cash flows and schedules on the Route 128 Add-a-Lane (Contract IV) in Dedham and Needham and for costs of Crosby's Corner in Concord and Lincoln. Staff has worked within the updated fiscal constraints and proposed a Revised Staff Recommendation that seeks to include as many projects as possible from the initial two scenarios.

The initial Staff Recommendation Scenarios were introduced by the memorandum "Assumptions for Development of the Staff Recommendation" (March 23, 2012), which provided information on the assumptions and factors considered by MPO staff in the development of the Staff Recommendation for the FFYs 2013-16 TIP. That memorandum presented two scenarios.

The present memorandum provides information on the project updates, sets forth the Revised Staff Recommendation, and summarizes the changes between the initial two scenarios and the revised recommendation. It supersedes the March 23 memorandum.

TIP PROJECT UPDATES AND CHANGES

The Route 128 Add-a-Lane (Contract IV) project does not need approximately \$6 million of its funding in FFY 2012. The Revised Staff Recommendation moves approximately \$6 million for the Route 128 Add-a-Lane (Contract IV) from FFY 2012 to FFY 2013. The approximately \$6 million freed up by this step in FFY 2012 can be used to make advanced construction (AC) payments on Concord & Lincoln--Crosby's Corner. Additional non-target funds were also obligated to the Concord & Lincoln--Crosby's Corner project in FFY 2011. These two factors reduce the proposed AC payments for Crosby's Corner in FFY 2014 and FFY 2015. This in turn, increases the amount of target funds available for projects in FFY 2015 to program additional projects.

Based on these updates, a Revised Staff Recommendation was necessary to comply with fiscal constraint and to program the additional target funds made available. The Revised Staff Recommendation seeks to combine the two initial scenarios proposed while adhering to the project priorization factors of project rating, project readiness, Long-Range Transportation Plan time band, and geographic equity. These are discussed in the section "Assumptions" on the last page of this memo. The Revised Staff Recommendation also addresses MassDOT guidance to program more CMAQ-eligible projects than the minimum regional CMAQ target of approximately \$8.6 million annually.

STAFF RECOMMENDATION

The Revised Staff Recommendation would program 12 new projects, including 10 projects from the First-Tier List.

It includes the following new projects initially proposed in both Scenario One and Scenario Two:

- Boston Improvements to Commonwealth Avenue
- Quincy- Intersection & Signal Improvements at Hancock Strett & East/West Squantum Streets
- Brookline Intersection & Signal Improvements at Route 9 & Village Square (Gateway East)
- Melrose- Intersection & Signal Improvement to Lebanon Street
- Bedford, Billerica, Burlington- Middlesex Turnpike Improvements, Phase III
- Hanover- Reconstruction of Washington Street (Route 53)

It includes the following new projects initially proposed in either Scenario One or Scenario Two:

- Salem Reconstruction on Canal Street
- Danvers Reconstruction of Liberty Street
- Winchester, Stoneham and Woburn Tri-Community Bikeway
- Medway Reconstruction of Route 109 (Main Street)
- Beverly Reconstruction & Signal Improvements on Rantoul Street (Route 1A)
- Marlborough Reconstruction of Route 85 (Maple Street)

It does not include the following new project initially proposed in both Scenario One and Scenario Two:

• Wayland - Signal & Intersection Improvements at Route 27 (Main Street) and Route 30 (Commonwealth Road)

It does not include the following new project initially proposed in Scenario Two:

• Acton, Maynard - Assabet River Rail Trail

FIRST-TIER LIST OF PROJECTS

Staff uses the project evaluations and information on readiness to create a First Tier List of projects. The First Tier List comprises projects that:

- Evaluate well
- Could be made ready within the scope of the TIP under development

The list should also be related to the financial scope of the TIP, and is intended to be used as a resource for programming to fiscal constraint. This year, TIP targets are larger, so the cost-value of the list is expanded to approximately \$120 million and more projects are included. Also, it is large enough to serve as a resource for future possible programming decisions over the course of the upcoming year. The First Tier List is posted.

Staff also has updated the costs for the First Tier projects and has gathered information, over and above current design status, on realistic readiness. This information is critical for choosing the year in which it would be possible to program a project.

STAFF RECOMMENDATION ASSUMPTIONS

The following is a list of the assumptions that underpin the Staff Recommendation:

- The First Tier List is the primary source of projects for the recommendation. Projects that rate highly should be given priority in programming. Implementing them will do more to advance the MPO's visions and policies.
- The First Tier List and Staff Recommendation should work within the framework set by the Long-Range Transportation Plan. If a project that rates well is programmed in an LRTP timeband that is not within the scope of this TIP, it has not been included in the First Tier List or Staff Recommendation. Clean Air and Mobility funding also follows LRTP parameters.
- Greater consideration is given to projects in the First Tier List that are at the 100% or 75% design stage in the early elements of the TIP. For the later years of the TIP, readiness is less important as a factor.
- The TIP should show geographic diversity across its total scope.
- Local priority is a consideration.
