#### WHAT TRANSPORTATION NEEDS DID THE METROPOLITAN PLANNING ORGANIZATION (MPO) IDENTIFY IN NORTH SUBURBAN PLANNING COUNCIL (NSPC) COMMUNITIES

The Boston Region MPO, which is responsible for allocating federal funds to transportation projects and planning for the Boston region's transportation future, conducted an assessment of transportation needs in the Boston region to inform the MPO's Long-Range Transportation Plan (LRTP), *Destination 2050*. The LRTP and Needs Assessment inform the MPO's planning and policy work and guide the MPO's investments in transportation infrastructure projects each year through its rolling capital plan, the Transportation Improvement Program (TIP).

The following information highlights some transportation needs identified in the NSPC subregion based on MPO staff's analyses and past engagement with NSPC communities. This booklet also contains a list of NSPC projects currently programmed in the TIP.

# Transportation Needs Identified in the LRTP Needs Assessment

The MPO identified transportation needs throughout the Boston region during the development of the *Destination 2050* LRTP through public engagement and data analyses conducted between 2019 and 2022. These needs are documented in the *Destination 2050* <u>Needs Assessment StoryMap collection</u>. Key themes from the Needs Assessment are listed here by goal area.
